

2023 Individual and Small Group Hearings and Public Comment Forum

On May 6, 2022, the Green Mountain Care Board (GMCB) began its review of the proposed rates for major medical insurance plans offered to individuals, families, and small businesses in Vermont in 2023, including plans offered on Vermont Health Connect. The Board will hold hearings on the proposed rates on July 18, 2022 (BCBSVT) and July 20, 2022 (MVP) starting at 8:00 a.m. The Board encourages the public to attend the hearings and will take public comment at the end of each day's testimony. Additionally, the Board has scheduled an evening public comment forum on July 21, 2022 from 4:00 p.m. to 6:00 p.m. The Board is accepting public comment until July 21, 2021 at 11:59 p.m. The rate filings are posted at ratereview.vermont.gov.

All Board members, staff, and participants will be accessing the hearings and forum via Microsoft Teams. As required by Vermont's Open Meeting Law, a physical location is also available to members of the public.
