Join via web (preferred)

Please mute yourself when entering the meeting. The mute/unmute button is the microphone icon.

Join via phone

Dial the phone number provided and, when prompted, dial the conference ID number and then press #. Please be sure to mute yourself when you are not speaking. To unmute the phone, press *6.

Wi-Fi Connection

If you do not have a reliable Wi-Fi connection, you may want to use the dial-in number for your listening and audio connection while also using the Microsoft Teams link for video. Please remember to mute the microphone on Microsoft Teams and computer’s speakers to avoid feedback.
