# MVP'S RESPONSE TO THE GREEN MOUNTAIN CARE BOARD'S JUNE 7, 2021 QUESTION NO. 12

MVP Health Plan, Inc., ("MVP") by and through Primmer Piper Eggleston & Cramer PC, hereby responds to Question No. 12 of the Green Mountain Care Board's ("GMCB" or "Board") June 7, 2021 Questions ("Board Questions") as follows:

## **QUESTION NO. 12**

12. The Board is working to better understand the variability in reimbursement paid to hospitals. How long would it take MVPHP to calculate the following and does it have any alternative approaches that could be completed sooner?

For each Vermont general/community hospital and for the Dartmouth-Hitchcock, the ratio of MVPHP's inpatient inpatient reimbursement Medicare's reimbursement, to standardized by MS-DRG relative weights, and the ration of MVPHP's outpatient reimbursement to Medicare's outpatient reimbursement, standardized by APC relative weights (in a similar format as MVPHP provided last year in response to question 15 of the Board's post-hearing questions).

Response: MVP proposes filing the result of the Board's requested calculation on June 25, 2021 with MVP's Responses to Board Questions Nos. 1-11. MVP does not anticipate any time savings in running an alternative calculation to the calculation the Board requests.
