## **MEMORANDUM IN LIEU OF HEARING**

Pursuant to Green Mountain Care Board (GMCB) Rule 2.309(a), Blue Cross and Blue Shield of Vermont (Blue Cross VT) respectfully requests that the GMCB approve, without modification, the filing reflected in the *Blue Cross and Blue Shield of Vermont 2025 Large Group Unit Cost Trend Filing* (Blue Cross VT Filing) and as amended by Blue Cross VT's

Responses to Objections.

Blue Cross VT primarily relies on, and fully incorporates herein, all of its previous filings with the GMCB regarding this matter, and in an effort to avoid any confusion, Blue Cross VT respectfully reminds the GMCB that it amended its filed CTR component to 7% by way of response to Mr. Ruggeberg's questions dated July 18, 2024. In its Solvency Letter<sup>1</sup>, which in part responded to Blue Cross VT's amended request for 7% CTR, the Department of Financial

Regulation concluded that:

[Blue Cross VT] has indicated to the Department the company will be adjusting the CTR factor from 3.0% to 7.0%. The Department supports this increased CTR and finds it necessary to increase and stabilize reserves of [Blue Cross VT]. Any downward adjustments to the filing's other rate components that are not actuarially supported may prevent [Blue Cross VT] from meeting the necessary CTR and will further reduce [Blue Cross VT's] surplus and negatively impact its solvency.
