Subject: Your 03/17/2023 Questions re: Blue Cross and Blue Shield of Vermont 2024 Large Group Rating Program Filing (SERFF Tracking #: BCVT-133551255)

Dear Mr. Ruggeberg:

In response to your request dated March 17, 2023, here are your questions and our answers:

1. The memorandum indicates that unit cost trends for budget-impacted facilities will vary significantly between CY2023 and CY2024. However, it also states that "the GMCB will approve hospital budgets for October 1, 2023, and October 1, 2024, that support identical commercial increases as those approved for October 1, 2022." The statement regarding adjustments for adjustments based on recent information was withdrawn in your prior response. Please provide further detail regarding the assumed unit cost increases for budget-impacted hospitals.

We assume the GMCB would approve hospital budgets for the FY 2024 cycle that support commercial increases halfway between those approved for October 1, 2022 and those approved for October 1, 2021.

2. Please provide the parameters (auto-regressive and seasonality) of the Holt-Winters models used in setting the facility and professional trends (48-, 24-, and 18-month).

3. Please provide the number of professional visits PMPM by month from September 2018 through August 2022, consistent with the population used to population exhibit 2B, separated between PCP and non-mental health other professional.
